I understand and acknowledge that I have spoken to my child about his/her need to comply with all of Minato School's rules and requirements for this activity and that Minato School's rules and policies apply to my child and the other students during this activity. I hereby waive all claims against Minato School and its directors, officers, employees, agents, insurers, staff, teachers, volunteers, PTA, successors and assigns (collectively, the "Released Parties"), for any damages for injury to my child arising from the operation of a motor vehicle in connection with the activity.

**RELEASE: To the fullest extent allowed by law, I hereby release, waive and discharge the Released Parties, and agree not to sue any of them on account of or in connection with any claims, causes of action, injuries, damages, cost or expenses arising from or related to my child's participation in the activity, including any claims arising out of the operation of a motor vehicle in connection with transportation for the activity, and including any claims based on death, bodily injury and/or property damage regardless of fault, and whether caused by the active, passive, sole or contributory negligence of any Released Party.**

I also understand that this activity may expose my child to some risks and I assume all risks that may arise from the activity. I, and only I, will be fully responsible for all expenses related to any injuries that might occur to my child by reason of his/her participation in the activity.

I agree to pay for all costs to repair or replace (as determined by Minato School) any facilities, supplies or other property damaged by my child and/or myself while participating in the activity, whether such property belongs to Minato School, Madison High School, or any other person.

I confirm that I have carefully read this Consent and Release form and agree to its terms knowingly and voluntarily.

I understand that I do not have to sign this Consent and Release form, however if I do not, my child will **not** be permitted to participate in the activity.
